An application for review must be signed by the registrant shown on the Registration Form, or by his/her guardian/appointee/agent who has registered on his/her behalf using Forms B1, B2, C(O), D, D(OS) or D(CPH).

Remarks

- 1. A registrant or his/her guardian/appointee/agent who has registered on his/her behalf may, upon receiving an SMS or written notification indicating the registrant's ineligibility for payment under the Scheme, apply for a review in writing within 14 days from the date of receipt of the SMS or written notification if he/she has any objection. Late applications will not be accepted unless with justifications.
- 2. The applicant should submit the completed application form for review together with a copy of the relevant SMS or written notification and other relevant documents to the Consumption Voucher Scheme Secretariat ("the Secretariat") in person, by fax (no. 3106 0701), by email (enquiry@consumptionvoucher.gov.hk) or by post (GPO P.O. Box 185000, Hong Kong). No postage stamp is required if posted in Hong Kong (the postage will be borne by the Government).
- 3. The Secretariat will acknowledge receipt of the application for review. The Secretariat may ask the applicant for additional information. It is voluntary for the applicant to provide the required information. However, the Secretariat may not be able to process the application if the information provided is insufficient. Depending on the merits of the case, the Secretariat may consult relevant government bureaux and departments.
- 4. The Secretariat will normally notify the applicant of the result of the review, the follow-up actions taken and his/her right to appeal (where applicable) by SMS within six weeks from the date of receipt of his/her application for review and relevant documents. If the review cannot be completed within the said time frame, the Secretariat will send an interim reply, to be followed by a substantive reply through SMS on the result of the review as soon as possible.
